The mare owner will then fill out the Birth Report at the bottom of this page and submit it along with a **copy of the mare's registration papers to the FHS office within 28 days of the birth of the foal**. It may be faxed, e-mailed, or mailed to the FHS office below.

**Embryo Transfer (ET) must be approved by the FHS office prior to breeding**
