3. Fees

All fees are set except for the costs of boarding your horse at the judging site and your own lodging. The travel fee includes the cost of airline tickets, lodging, and land travel of the judging team divided by the total number of horses presented for keuring or judging. The cost for boarding your horse etc. may be collected by the host of your judging site.

Payment for all FHS fees (refer to fee schedule below) including the travel fees must be paid with this form when submitted. **Be advised that while we will make every effort to keep the travel cost to \$150 per horse, a fuel surcharge may need to be added depending on airline prices when we actually book the judges' flights.**

- Stallions are in tact males that are 3 years of age or older. A stallion is only entered to be Keured if the owner is seeking to find out if the stallion’s quality is good enough to try and achieve final breeding approval.
- Breeding Certificate, Birth Report and Foal Registration Form (including fees) must be on file with FHS.
- The hair sample for DNA may be collected at time of presentation of the foal if it has not already been submitted. Please understand that this could delay registration as parental verification is required on ALL horses.
- Microchips may be implanted prior or on the inspection day as long as it is done by a Veterinarian. If they have not been microchipped in advance, the “on site” veterinarian must do them at the inspection site.
- Please make sure you check with your judging site host about Coggins, Vaccination and Health Certificate requirements.

Each judging site should present a minimum of five (5) horses. If our judges have to make a special trip to a judging site with less than five (5) horses, the travel and Hotel costs will raise to the price of five (5) participating horses, divided among those who present at that site. (5 x \$150.00+ 5 x \$50.00)!

5. Instructions

- a) **DUTCH REGISTRATION NUMBERS** should be used whenever available for pedigree information!
- b) The horse owner must be an FHS member in good standing prior to the Inspection or Keuring.
- c) The horse must be registered with FHS or application for registration has been submitted.
- d) Fax, e-mail, mail, or fill out this form on the website. Send your check or credit card information for the appropriate fees, to our FHS address below **postmarked by July 31, 2009.**
- e) Foal Registration Form + Breeding Certificate *must* be on file with FHS prior to judging.
- f) Transfer of Ownership and/ or Change of Registry *must* be on file with FHS prior to judging.
- g) This Entry Form **MUST** be submitted no later than **July 31, 2009.**
A late fee (\$100.00 per horse) will be charged if your Entry Form is mailed and postmarked after July 31, 2008. On site entries will cost \$350 per horse.

New purchases will be granted an exception - transfer of ownership form needs to be submitted.

- h) No horse/foal will be allowed to be presented unless all fees have been collected **in advance**, including balance (if applicable) of the judges travel and hotel costs.
